ARTICLE I. NAME

The name of this corporation shall be Robert Herrmann, P.A.

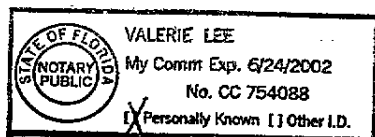


