ARTICLES OF INCORPORATION

OF

<u> ARTICLE I - NAME</u>

The name of the corporation is The Bayer-Lanza Company

ARTICLE II - PURPOSE

The aggregate number of shares which the Corporation shall have the authority to issue is 1,000 shares of common stock, par value \$.01 per share.


