**ARTICLES OF INCORPORATION**

In compliance with the requirements of Chapter 607 and/or Chapter 621, FS (Profit) the undersigned, being a natural person, hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation shall be Lynn's Precision Painting, Inc.

**ARTICLE II**

The street address of the principal office of the Corporation is 207 Lily Pad Lane, Eustis, FL 32726.

**ARTICLE III**

This Corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other State, Country, Territory or Nation.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is one thousand (1,000), par value one dollar (\$1.00) per share, all of which shall be common shares. All common shares shall be identical with each other in every respect and the holders of common shares shall be entitled to one vote for each share on all matters or which shareholders have the right to vote.
