ARTICLES OF INCORPORATION

OF

A R REALTY INVESTMENTS, INC.

The undersigned, of legal age, hereby form this corporation under the laws of the State of Florida.

ARTICLE I.

NAME

The name of this corporation shall be A R REALTY INVESTMENTS, INC.

ARTICLE II.

GENERAL NATURE OF BUSINESS


ARTICLE X.


