Pursuant to the provisions of Section 606.1006 of the Florida General Corporation Act, Undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

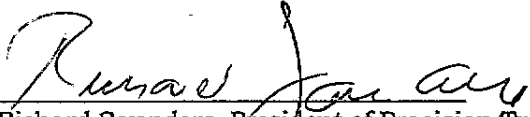
1. The name of the corporation is CALLIBUR CORPORATION

4. The number of shares voted in favor of such amendment was one (1), and the number of shares voted against such amendment was zero.

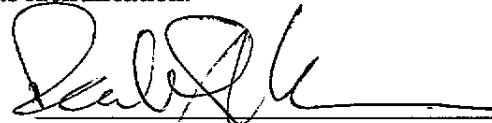
