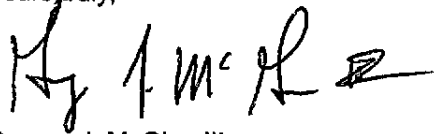

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the state of Florida.

**ARTICLE I. NAME**

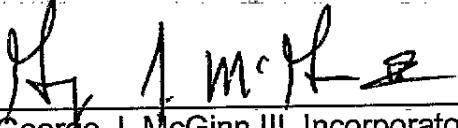

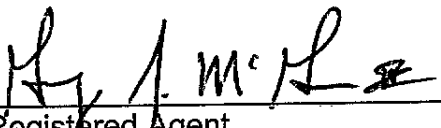
