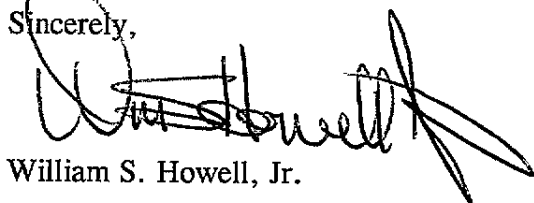

ARTICLE I

NAME AND BUSINESS ADDRESS OF CORPORATION

The Registered Agent of the Corporation and his address shall be:

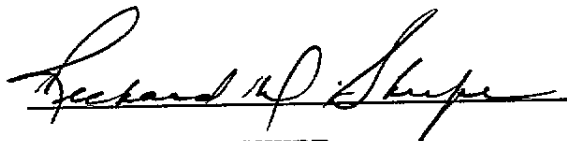

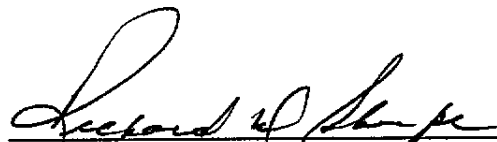

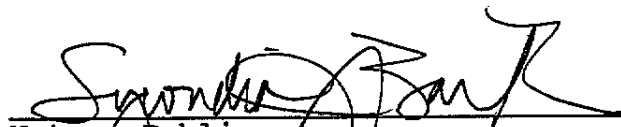
