ARTICLES OF INCORPORATION

OF

SELLENERGY.COM, INC.

I, the undersigned, hereby make, subscribe, acknowledge, and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

Name and Mailing Address

The name of this corporation shall be:

Existence of Corporation

This corporation shall begin existence on the day of the filing of these Articles and shall have perpetual existence.

<u>Purposes</u>

This corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida.
