ARTICLES OF INCORPORATION DOG ENTERPRISES, INC.

The undersigned, acting as incorporator of DOG Enterprises, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME
