I am writing to request a waiver of the late fee in the filing of the Uniform Business Report for Widereach-Entertainment & Rifenet.com, Inc.


Reasons are listed below:

At this point we would like to implore the late fees be waived not only because of the above mentioned reasons but also because during the floods and storms of October both my partner and myself lost all of our belongings including all pertinent equipment to operate the business. We never filed any papers with FEMA or the SBA because at that point we did not realize how great the damage was. We also lost the one major contract that would have been essential for our business to succeed. At that point, we were going close down the business however due to recent developments we decided to give it one more change to survive. We ask that you give us an opportunity by waiving the late fee. We commit ourselves to organizing our business and not repeating our mistake.
