ARTICLES OF INCORPORATION

of

SO WAY SO THE SE **DELTA'S CHRISTIAN ACADEMY INC.**

I, the undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby certify as follows:

ARTICLE I - NAME

The name of the Corporation shall be:

DELTA'S CHRISTIAN ACADEMY INC., a Florida corporation

ARTICLE II - PURPOSE

To carry on and engage in the operation of a nursery, daycare and pre-school center for small children and to perform all other acts which may be necessary or related thereto.

ARTICLE III - CAPITAL STOCK

The Corporation shall be authorized to issue capital stock in the following manner, to wit: FIFTY (50) Shares of Common Stock, having no par value.

ARTICLE IV - POWERS
