ARTICLES OF INCORPORATION

OF

Tecnovida.com, Inc.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, Florida Statutes, Section 607, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is **Tecnovida.com, Inc.**

ARTICLE II - DURATION

This corporation shall have perpetual existence, effective upon the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

The purpose is to engage in any and all business activities permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One Hundred Million (100,000,000) shares of no par value common stock.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon shareholders and the Board of Directors is subject to this reservation.

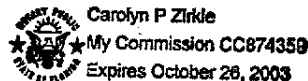
