# ARTICLES OF INCORPORATION

## HIDDEN ROAD FARM, INC.

We, the undersigned incorporators, for the purpose of forming a corporation under Florida law, hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be:

## ARTICLE II: PURPOSE

HIDDEN ROAD FARM, INC. shall be organized under Florida Statute Chapter 607 as a forprofit corporation with the purpose of the general care, welfare and maintenance of horses, which

HIDDEN ROAD FARM, INC. may invest its corporate funds into real estate, mortgages, stocks, bonds, and any other type of investments, and may own real and personal property necessary for the rendering of the services authorized hereby. HIDDEN ROAD FARM, INC. may engage employees, contractors, subcontractors, et al. for business purposes. Further, HIDDEN ROAD FARM, INC., may engage in any and all other lawful corporate activities.

## ARTICLE III: PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be in Palm Beach County, Florida.

#### ARTICLE V: SHARES

The maximum number of shares of stock that this for profit corporation is authorized to have outstanding at any one time shall be forty (40) shares with an initial par value of two hundred and fifty dollars (\$100.00) per share, all of which shall be common stock of the same class.

#### ARTICLE VI: OWNERSHIP OF SHARES

Ariane Vasquez, acting as Director of HIDDEN ROAD FARM, INC., shall be issued and hold twenty (30) shares of common stock. The balance of the issued shares shall be kept by HIDDEN ROAD FARM, INC. as reserves.

#### ARTICLE VII: EXISTENCE

The corporation shall have perpetual existence.

### ARTICLE VIII: BOARD OF DIRECTORS/INCORPORATORS

### ARTICLE IX: MANAGEMENT/AFFILIATION

In furtherance and not in limitation of the powers conferred by statute, the following specific provisions are made for the regulation of the business and conduct of the affairs of HIDDEN ROAD FARM, INC.

(1) Such directors/shareholders of HIDDEN ROAD FARM, INC. shall from time to time create, readdress and amend by-laws for the corporation, as the directors/shareholders should see fit.

(2) Subject always to such by-laws as may be adopted from time to time by the stockholders, the board of directors of HIDDEN ROAD FARM, INC. is expressly authorized to adopt, alter and amend the by-laws of the corporation, but any by-law adopted, altered or amended by the directors may be altered, amended or repealed by the stockholders.

(3) The corporation shall have such officers as may from time to time be provided in the bylaws and such officers shall be designated in such manner and shall hold their offices for such terms and shall have such powers and duties as may be prescribed by the by-laws or as may be determined from time to time by the board of directors subject to the by-laws.

(4) Subject to the restrictions, if any, as are herein expressed and such further restrictions, if any as may be set forth in the by-laws (not attached), the board of directors of HIDDEN ROAD FARM, INC. shall have the general management and control of the business and may exercise all of the powers of the corporation except such as may be by statute, or by the articles of incorporation or amendment thereto, or by the by-laws as constituted from time to time, expressly conferred upon or reserved to the stockholders.
