ARTICLES OF INCORPORATION OF
SUNDODGER ICE, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I
NAME

The name of the corporation is Sundodger Ice, Inc.

ARTICLE II
PRINCIPAL OFFICE


