**ARTICLES OF INCORPORATION
OF
PRUS, Inc.
a Florida corporation**

The undersigned incorporator, MELISSA E. JOHNSON, a natural person competent to contract, and with the consent of the owners, officers and directors of the corporation created hereby, presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is **PRUS, INC.**, a Florida corporation.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 126 South Shore Drive #34, Destin, Florida 32541.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one thousand (1,000) shares of \$1.00 par value common stock.

ARTICLE V - TERM OF EXISTENCE


