ARTICLES OF INCORPORATION

OF

Article I - Name

The name of this Corporation is The HOB Group, Inc.

Article II - Duration

This corporation shall have perpetual existence.

The name and address of the registered agent of this Corporation is James P. Talsky, located at 2260 NW Pine Avenue, Ocala, Florida 34475.


Article VII - By-laws

This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares pre-empted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms, and conditions of the issue of shares, and inviting him to exercise his pre-emptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.

Article XII - Amendment

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholders meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

ARTICLE XIII - Registered Agent Certificate of Designation

The HOB Group, Inc., desiring to organize under the laws of the State Of Florida, with its principal office in the City Of Ocala, County Of Marion, and State Of Florida, has named James P.
