RE: CORPORATE REINSTATEMENT

Dear Sir or Madam:

I have learned just this past Friday afternoon that my corporation, Superior Home Loan & Mortgage Company, Inc (organized in 2000 as a sub-chapter S corporation) was dissolved in 2001 for failure to pay the annual fee and file the proper annual report.

Upon learning of this situation Friday afternoon, I began to search for an answer as to 'Why' and 'How' this could have happened. I began to attempt to sift through what is left of my files - most of my records were lost as a result of Hurricane IVAN - and unfortunately that includes my tax records and bank statements - looking for any evidence that the forms were filed and fees paid. However, most were turned to trash and nothing could be found.

However, I also do not recall seeing any other 'notice' or other forms from your department alerting me of the impending administrative action. I can only believe that I was missed in the mail due to relocation from 114 Cousineau Rd in Pensacola in mid 2000. Though my address was forwarded, any other notices from your department may not have found me. Such a notice would have surely gotten my attention and immediate action would have been taken. Instead, I find that I have been doing business under the same name using the 'Inc' designation since 2001.

Upon calling your department this morning I learned also the total fee would be on the order of \$1,200. The representative suggested I write this letter, ask for a wavier of the \$600 fee, and send a check (enclosed) for \$600. Your department would review my situation and act accordingly.

In my defense, I would add that this issue was only raised during the normal course of business. A lender I have made application to (one of dozens over the past three years) routinely checked the state website to make sure all applying brokerages are valid. They altered me to the situation.

Neither I, nor Superior Home Loan & Mortgage Company (Inc) have any previous or current complaints or lawsuits pending. My desire to remedy this situation is entirely voluntary and in an attempt to comply with all the rules, regulations, and laws of the state of Florida. In fact, since inception

Further I will take all necessary steps to insure the timely filing of proper reports, and prompt payment of all required fees, henceforth.
