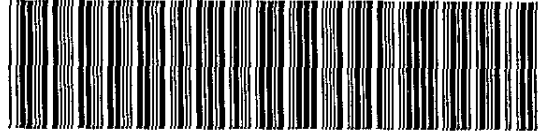

ARTICLE VI:


1. Amend Article: To remove the name of Marev Dahaman as President and director of the company.

Amendment was adopted by the board of directors without shareholder action. Shareholder action was not required pursuant to the provisions of Florida Statute 607.1002.




