ARTICLE I - NAME AND PRINCIPAL LOCATION

The name of this corporation is " Logan Mercantile, Inc." The principal location of the corporation is 601 Sabal Lake Drive, #107, Longwood, Florida 32779.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The general nature and purposes of the business to be transacted, promoted and carried on by the corporation are as follows: the sale and purchase of wholesale and retail merchandise, and engaging in any act, duties or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

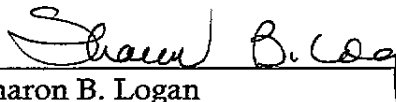

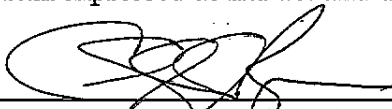
