ARTICLES OF INCORPORATION OF
VICKI CATSIMPIRIS INSURANCE AGENCY, INC.

The undersigned incorporator, being a natural person competent to contract, and for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1.
CORPORATE NAME

The name of this corporation shall be Vicki Catsimpiris Insurance Agency, Inc.

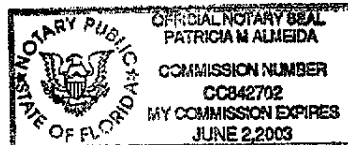
