The undersigned, being a natural person licensed or otherwise legally authorized to practice medicine and desiring to form a professional association pursuant to the Professional Service Corporation Act and pursuant to the laws of the State of Florida, do hereby certify as follows:

ARTICLE I – NAME

The name of this professional association shall be John E. Bianco, MD, P.A.

ARTICLE II - NATURE OF BUSINESS/PURPOSE

This professional association is organized for the sole and specific purpose of rendering the same services to the public which are rendered by physicians and the general nature of this business to be transacted by this professional association is as follows:

- A. The foregoing paragraphs shall be construed as enumerating both objects and purposes of this professional association; and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict

in any manner the purposes of this professional association otherwise permitted by law.

ARTICLE III - CAPITAL STOCK

The maximum number of shares or capital stock that this professional association shall be authorized to issue is One Thousand (1000) shares of common stock with a par value of One Dollar (\$1.00) per share.
