The undersigned, being a natural person licensed or otherwise legally authorized to practice medicine and desiring to form a professional association pursuant to the Professional Service Corporation Act and pursuant to the laws of the State of Florida, do hereby certify as follows:

ARTICLE I - NAME

The name of this professional association shall be John E. Bianco, MD, P.A.

ARTICLE II - NATURE OF BUSINESS/PURPOSE

This professional association is organized for the sole and specific purpose of rendering the same services to the public which are rendered by physicians and the general nature of this business to be transacted by this professional association is as follows:

- A. To engage in every phase and aspect of the profession of rendering the same professional services to the public that a physician, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees, and agents who are duly licensed under the laws of the State of Florida to practice medicine therein.
- B. To invest the funds of this professional association in real estate, mortgages, stocks, bonds or any other type of investment, and to own real and personal property necessary for the rendering of such professional services.
- C. To do all and everything necessary and proper for the accomplishment of any of the purposes of the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Incorporation or any amendment thereof, necessary or incidental to the protection and benefit of the professional association, and in general, either along or in association with other corporations, associations, firms, or individuals to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes of the attainment of the objects or the furtherance of such purposes or objects of this professional association.

The foregoing paragraphs shall be construed as enumerating both objects and purposes of this professional association; and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict

in any manner the purposes of this professional association otherwise permitted by law.

ARTICLE III – CAPITAL STOCK

The maximum number of shares or capital stock that this professional association shall be authorized to issue is One Thousand (1000) shares of common stock with a par value of One Dollar (\$1.00) per share.

ARTICLE IV – DURATION

The association shall have perpetual existence.

ARTICLE V – PRINCIPAL OFFICE

The initial street address of the principal office of this professional association is 10203 Allenwood Drive, Riverview, Florida 33569.

ARTICLE VI – INITIAL OFFICERS/DIRECTORS


ARTICLE IX - AMENDMENT
