ARTICLES OF INCORPORATION

SUSAN DUNCAN, INC.

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

ARTICLE !

The name of this corporation is SUSAN DUNCAN, INC., with its principal office located at 1156 John Anderson Drive, Ormond Beach, Florida 32176.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The general nature of the business to be transacted by this corporation is as follows:

- (a). To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.
- (b). To own, by purchase or otherwise, lease, rent or in any other manner lawfully acquire and operate a cocktail lounge, bar, restaurant, diner; to own and purchase all necessary licenses for the operation of a facility selling alcoholic and non-alcoholic beverages.
- (c). To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any manner reproduced.
