ARTICLE I-NAME

This corporation shall exist perpetually, commencing on the
day of signing.

This corporation shall have all of the corporate powers, as enumerated in the Florida Statue covering Professional Associations, as well as the power to act as trustee.

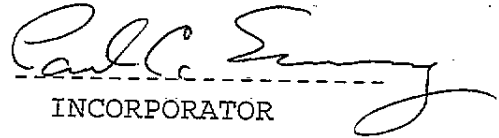
ARTICLE X-INDEMNIFICATION

ARTICLE XI-AMENDMENTS

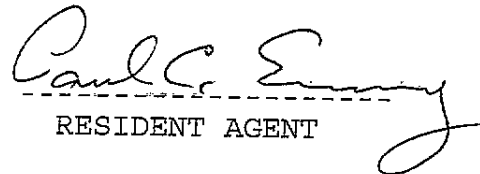
