ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of Cielo Sport & Family Chiropractic Centre, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:

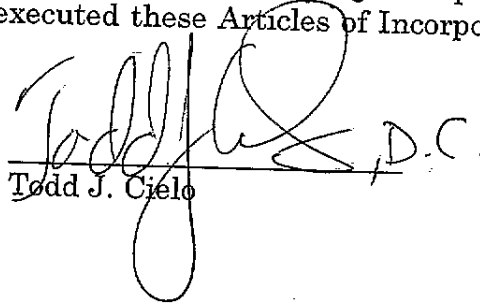
## ARTICLE IX. BYLAWS

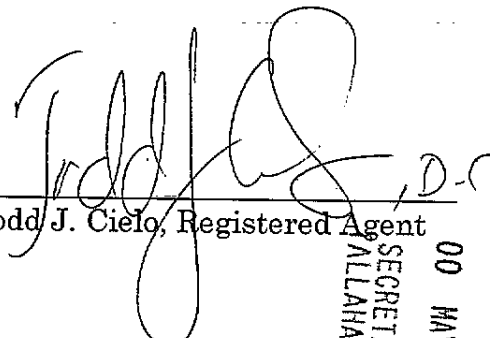
