Therefore, please find the completed 2001 Uniform Business Report for Sunstate Beauty Supply, Inc. I have also enclosed a check in the amount of \$150.00 for the required filing fee.

It is my understanding that failure to file prior to May 1 would result in a filing fee of \$550.00. Please consider this letter as my request that the Division of Corporations waive the additional fee.
