

ARTICLES OF INCORPORATION
OF

Lucille Silin Corp.

ARTICLE ONE:

The name of the corporation is: Lucille Silin Corp.

ARTICLE TWO:

The period of its duration is perpetual.

ARTICLE THREE:

The purpose for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Florida Corporation Act.

The aggregate number of shares which the corporation shall have authority to issue is ten thousand (10,000) of the par value of one dollar (\$1.00) each.

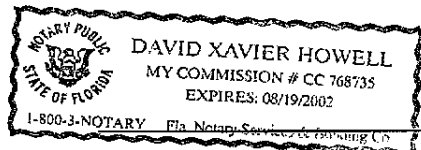


