The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I - NAME**

The name of this corporation is Heavenly Wreckers, Inc.

**ARTICLE II - DURATION**

This corporation shall exist in perpetuity commencing on the date of the execution and acknowledgement of these Articles.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose to engage in any activities or business permitted under the laws of the United States and Florida.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue one thousand (1,000) shares of ten cents (\$0.10) par value common stock which shall be designated "Common Shares."

**ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of this corporation is 3840 E. S.R. 46, Sanford, FL 32771, and the name of the initial registered agent of this corporation is Jorge Alfonso, 3840 E. S.R. 46, Sanford, FL 32771, who by his signature at the end hereof, accepts such designation.

**ARTICLE VI - INITIAL BOARD OF DIRECTORS**

This corporation shall have five (5) directors initially. The number of directors may be either increased or decreased from time to time by an amendment of the By-Laws of this corporation, in the manner provided by law, but shall never be fewer than one (1).

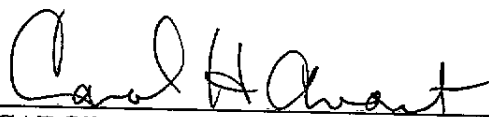
