ARTICLES OF INCORPORATION OF

SECRETARY OF STATE OVIEDO SCREEN REPAIR & MAINTENANCE CORPTALLAHASSEE, FLORIDA

ARTICLE I. NAME

The name of this corporation is:

OVIEDO SCREEN REPAIR & MAINTENANCE CORP.

ARTICLE II. PURPOSE

This corporation is organized for the following purposes:

To engage in any or all lawful business for which a corporation may be incorporated under the laws of Florida.

ARTICLE III. POWERS

- a. To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed or in any other manner reproduced.
- To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in and with real or personal property or any interest therein, wherever situated.
