ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Lincoln Michigan Corporation

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 2363 N. Meridian Avenue Miami Beach, Florida 33140

ARTICLE III - PURPOSE
