

ARTICLES OF INCORPORATION

OF

FREEDOM AUTO SALES, Inc.

The undersigned incorporator(s), being an individual duly licensed to render automobile sales and service, hereby form a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I. CORPORATE NAME.

The name of the corporation shall be: FREEDOM AUTO SALES, Inc.
