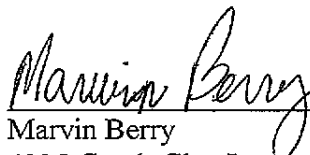

ARTICLES OF INCORPORATION
OF
MASTER POLISHERS, INCORPORATED

ARTICLE I

The name of the Corporation is Master Polishers, Incorporated.

ARTICLE II

The principal place of business and mailing address of this corporation shall be Master Polishers, Incorporated, 4335 Creek Glen Lane, Lakeland, Florida 33811.

ARTICLE III

The general nature of the business and the object and purpose of the business proposed to be transacted and carried on are to any and all of the things herein noted, as fully and to the same extent as natural persons might or could do, to wit:

1. To engage in the business of vehicle detailing, polishing and cleaning and other products and services deemed appropriate.
2. To enter into and perform any/all contracts in which any person, firm, corporation or association may lawfully engage and especially those dealing with all the aspects of the above-referenced products and services.
3. To carry on any other lawful business whatsoever in connection with the foregoing whether calculated directly or indirectly to promote the interest of the corporation or to enhance the value of the properties of the corporation.

4. To do each and every thing necessary, suitable, or proper for the accomplishment of any of the purposes or attainment of any one or more of the objects herein, or which shall at any time appear conducive to or expedient for the protection and benefit of this corporation.
5. The foregoing enumeration of specific powers shall not be deemed to limit or restrict in any manner the general powers of the corporation, and the enjoyment and exercise thereof, as conferred by the laws of the State of Florida upon corporations under the provisions of law.

ARTICLE IV

The aggregate number of shares which the Corporation has authority to issue is 1,000 shares of common stock with the par value of \$1.00 per share.

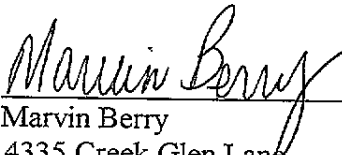
ARTICLE V
