ARTICLES OF INCORPORATION

OF

LINCOLN ALLEN CIVIL ENGINEERING GROUP, INC.

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is Lincoln Allen Civil Engineering Group, Inc., and the principal address is 3354 20th Avenue S.W., Largo, FL 33774.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is 3354 20th Avenue S.W., Largo, FL 33774. The name of its registered agent at such address is Scott Andrew Lincoln.

ARTICLE III - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Florida.

ARTICLE IV - AUTHORIZED SHARES OF STOCK
