Pursuant to Chapter 607 of the Florida Business Corporation Act, the undersigned adopts these Articles of Incorporation for the purpose of forming a for-profit corporation, to have and to exercise all of the powers now or hereafter conferred by the laws of the State of Florida upon corporations and any and all acts amendatory thereof and supplemental thereto.

**Article 1 - NAME**

The name of the Corporation is: CB Ventures, Inc.

**Article 2 - BY-LAWS**

The power to adopt, alter, amend or appeal By-Laws shall be vested in the Board of Directors and the Shareholders.

**Article 3 - CAPITAL STOCK**

The Corporation is authorized to issue one class of stock, that being 1,000,000 (one million) shares with a par value of \$1.00 (one dollar, U.S.), common stock, with identical rights and privileges, the transfer of which is restricted according to the By-laws of the Corporation.
