OF

The ARTICLES OF INCORPORATION of ROSS PRITCHARD BUILDERS, INC., are as follows:

ARTICLE I.

The name of this corporation shall be **ROSS PRITCHARD BUILDERS, INC.**

The duration of this corporation is perpetual.

This corporation is organized for transaction of any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, or under the laws of the State of Florida, except that said corporation shall not conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.

The aggregate of shares of stock of said corporation shall be 100 shares of common stock with a par value of \$20.00.


The number of directors may be either increased or diminished from time to time by the By-Laws, but shall never be less than one (1). Directors may be removed for cause.

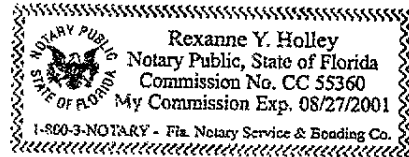
