ARTICLES OF INCORPORATION OF INTERCONNECT INTERNATIONAL, INC

The undersigned, for the purpose of forming a corporation hereby adopt the following Articles of Incorporation.

ARTICLE ONE NAME

The name of the Corporation is Interconnect International, Inc., 4532 W. Kennedy Blvd. #407, Tampa, FL 33609.

The term of existence of the Corporation is perpetual.
