ARTICLES OF INCORPORATION WASHINGTON SCREEN PRINTING, Inc.

THE UNDERSIGNED HEREBY ASSOCIATES THEMSELVES FOR THE PURPOSE OF ORGANIZING THIS CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA:

ARTICLE I The name of this corporation is Washington Screen Printing, Inc.

ARTICLE II The purpose of this corporation is to engage in any lawful business permitted under the laws of Florida as a Sub-chapter-S Corporation

ARTICLE III The duration of this corporation is to be perpetual.


