**ARTICLES OF INCORPORATION  
OF  
PROPERTY RESTORATION MANAGEMENT, INC.**

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is PROPERTY RESTORATION MANAGEMENT, INC., and the principal address and principal place of business is 719 17th Avenue North, St. Petersburg, Florida 33704.

**ARTICLE II - REGISTERED OFFICE AND AGENT**

The address of its registered office in the State of Florida is c/o STEVEN W. MOORE, P.A., 2240 Belleair Road, Suite 100, in the City of Clearwater, County of Pinellas, Florida 33764. The name of its registered agent at such address is Steven W. Moore.

**ARTICLE III - PURPOSE**

#### **ARTICLE VI - AMENDMENTS**

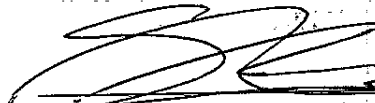
