The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

**CORPORATE NAME**

The name of the corporation is **ROBERT A. LUTZ INSURANCE, INC.** (the "Corporation").

**ARTICLE II**

**PRINCIPAL OFFICE**

The principal place of business and mailing address of the Corporation shall be 7163 Radio Road, Naples, Florida 34104.

**ARTICLE III**

**CAPITAL STOCK**

The Corporation is authorized to issue One Thousand (1000) shares in the aggregate, which shares shall be of a single class of common stock and each shall have no par value.

**ARTICLE IV**

**AMENDMENT**


These Articles of Incorporation may be amended by the assent of shareholders holding at least fifty-one percent (51%) of the issued and outstanding common stock of the Corporation.

The Corporation may be dissolved with the assent of shareholders holding not less than two-thirds (2/3) of the outstanding common stock of the Corporation.



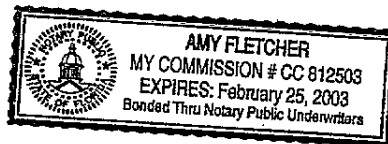
