ARTICLES OF INCORPORATION
OF

SCOTT E. ROVENGER, P.A.

The undersigned, all of whom are duly licensed to practice law in the State of Florida, desiring to form a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, adopt the following Articles of Incorporation:

I. NAME

The name of the professional Corporation is SCOTT E. ROVENGER, P.A.

II. PURPOSE

The purpose for which the Corporation is organized is to practice the profession of law.

III. ELECTION UNDER PROFESSIONAL CORPORATION ACT

The Corporation elects to be governed by the provisions of the Florida Professional Service Corporation and Liability Company Act, Florida Statutes Chapter 621 as may be hereinafter amended.

IV. DURATION

The term of existence of the Corporation is perpetual.

V. CAPITAL STOCK



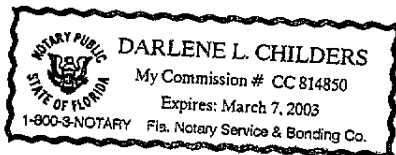
