ARTICLES OF INCORPORATION
FOR
OSCAR WHISKEY TRUCKING, INC.

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE ONE: The name of the Corporation is OSCAR WHISKEY TRUCKING, INC.

ARTICLE TWO: The duration of the corporation is perpetual.
