ARTICLES OF INCORPORATION OF ADAMS R&D, Inc.

ARTICLE I - NAME

The name of this corporation is ADAMS R&D, Inc. (hereinafter referred to as the "Corporation").

ARTICLE II - DURATION

The Corporation shall exist perpetually, commencing on the date of June 1, 2000 filing these Articles with the Department of State.

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business not inconsistent with the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK
The Corporation is authorized to issue 100 shares of (\$5.00) par value common stock.

ARTICLE V - PREEMPTIVE RIGHTS
