ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of this corporation is DACING TREE, INC.

ARTICLE II

The mailing address of the principal office and the initial mailing address shall be Post Office Box 12391, Gainesville, Florida 32604-2391. The street address is 705 Northwest 24<sup>th</sup> Avenue, Gainesville, FL 32609. These addresses may be changed at any time by a vote of the Board of Directors.

ARTICLE III

This corporation is organized for the following purposes:

- A. To engage in the management and operation of a business for computer programming, internet programming and web services.
- B. To engage in any lawful business permitted under the laws of the State of Florida and the United States of America.

ARTICLE IV

The period of its duration is perpetual.

## ARTICLE V

The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time shall be TWENTY THOUSAND (20,000) shares of voting common stock with a par value of ONE DOLLAR (\$1.00) per share, which may be paid for in cash, labor, services, or real or personal property.

## ARTICLE X

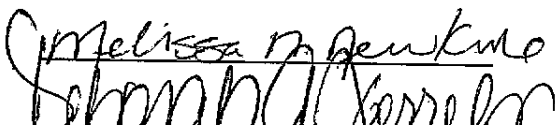
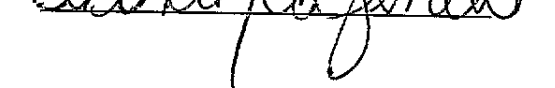

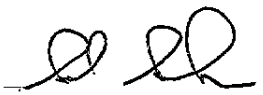
## ARTICLE XI

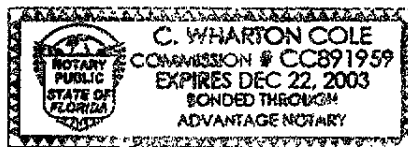
