**ARTICLE I  
NAME**

The name of this corporation shall be: Garage Door Doctors, Inc.

**ARTICLE II  
TERM OF EXISTENCE**

This corporation shall exist perpetually.

**ARTICLE III  
PURPOSE**

The general purposes for which the corporation is organized are:

- 1) To engage in the business of garage door replacement, service and repairs.
- 2) To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the preceding business.
- 3) To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

**ARTICLE IV  
CAPITAL STOCK**

This corporation is authorized to issue 100 shares of common stock. This class of stock shall have unlimited voting rights and be entitled to receive the net assets of the corporation upon its dissolution.




