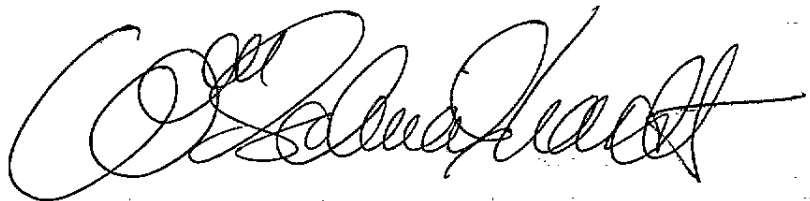

The principal office of this Corporation shall be located at 141 5th Street North, Naples, Florida 34102.

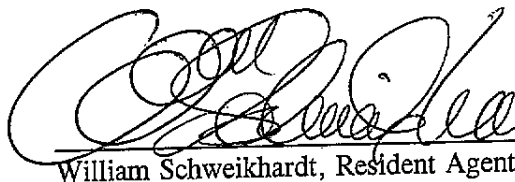

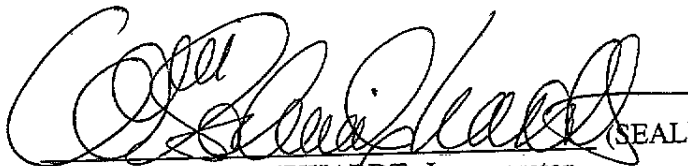
