# ARTICLES OF INCORPORATION OF 21ST CENTURY HOME BUYERS, INC.

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

## ARTICLE I - NAME
