That the name of this corporation is JERUSALEM GRILLE & DELI, INC.


ARTICLE II - ADOPTED AMENDMENT

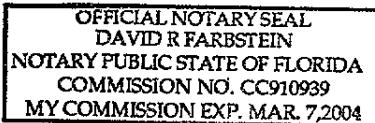


