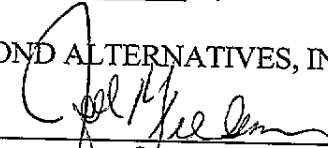
ARTICLE VI. REGISTERED AGENT. The initial registered agent of the corporation
