
**ARTICLE VI. REGISTERED AGENT.** The initial registered agent of the corporation



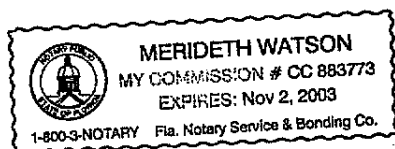


