The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be:

AAREMA Industries, Inc.

ARTICLE II

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these Articles, or upon the filing with the Secretary of the State of Florida in the event that these Articles are not filed within five (5) days, exclusive of holidays, after execution, and acknowledgment; and shall exist perpetually unless sooner dissolved by law.

ARTICLE III

PURPOSE

This corporation is organized to buy, sell, own, improve, develop, manage, rent, lease, control, and otherwise deal in and with real and personal property of every nature, and for the purpose of transacting any and all lawful business.

ARTICLE IV

CAPITAL STOCK

The authorized capital stock of this corporation shall consist of SEVEN THOUSAND FIVE HUNDRED (7500) shares of common stock with a par value of ONE DOLLAR (\$1.00) per share.

ARTICLE V

INITIAL CAPITAL

The amount of capital with which this corporation shall begin business will not be less than FIVE HUNDRED DOLLARS (\$500.00).

ARTICLE VI

ADDRESS

The address of the principal place of business shall be:

ARTICLE VII

OFFICERS
